The Sioux County Board of Commissioners met at the Sioux County Courthouse meeting room February 2, 2026 at 9:00 a.m. with the following present: Commissioners J.W. Geiser, Josh Skavdahl and Hal Downer. Also present was County Clerk Michelle Zimmerman. The pledge of allegiance was recited. J.W. Geiser opened the meeting in prayer. Reference was made to the Open Meeting Laws posted in the meeting room. Motion made by Downer, seconded by Geiser to approve the minutes of the January 2, 2026 meeting. Kerri Rempp, Discover Northwest Nebraska Director met with the board to discuss outfitters collecting and submitting lodging tax. Geiser stated that on some websites, the outfitters are offering lodging in addition to hunting services. Motion made by Geiser, seconded by Downer to approve Rempp sending a letter to the NE State Tax Commissioner for a final determination on the requirement of lodging/hunting services being subject to lodging tax. On roll call vote, Geiser, yes; Downer, yes, Skavdahl, yes. Motion carried.

Val Jansante, representative of Congressman Adrian Smith's office met with the board to update them.

Spike Jordan met with the board and discussed many Nebraska legislative issues.

Michelle Zimmerman, Sioux County Clerk, submitted financial reports to the board.

Lacy Klein, County Treasurer, submitted financial reports to the Board. Klein provided the delinquent tax sale list to the board.

Sheriff McCumbers provided a financial report and updated the board on recent activities, there have been changes in part-time staff.

At 10:15 a.m. a motion to enter inter executive session for the protection of the public interest was made by Downer, seconded by Geiser. Roll call vote, Geiser, yes; Downer, yes; Skavdahl, yes. Motion carried. At 10:34 a.m. a motion to reconvene to regular session with no action taken during executive session was made by Geiser, seconded by Downer. On roll call vote, Downer, yes; Geiser, yes; Skavdahl, yes. Motion carried.

Brock Ortner, Livestock Systems Educator for UNL Extension updated the board on upcoming events. Discussion was held regarding reproductive rates in cattle.

Austin Paxson, Project Manager with Nextera Energy and David Levy, Baird Holm, LLP met with the board regarding Sioux County Wind Farm, LLC's conditional use permit. David Levy and Austin Paxson provided a verbal report of the action steps taken before and since the date that the Sioux County, NE Board of Commissioners approved Nextera's conditional use permit for their conditional use (commercial wind energy electricity production), including regulatory agency permitting, surveying and securing a generation interconnection agreement with Black Hills Energy. Nextera will submit a written report on the progress of the project and thereafter every 6 months. Deputy County Attorney Skavdahl reviewed the Planning and Zoning Regulations regarding conditional use permits with the board. Motion made by Geiser, seconded by Downer to find that Nextera's permitted conditional use had lawfully commenced at the date of approval of Nextera's conditional use permit (May 23, 2024), and that the conditional use continued from that date through the current date. On roll call vote, Downer, yes; Geiser, yes; Skavdahl, yes. Motion carried.

Jay Sturdevant, Agate Fossil Beds Superintendent and Vince Davis, Facility Manager met with the board to discuss the resurfacing of the west end of River Road. Studies will be done this spring, with contracting done next summer. The speed limit on the road was discussed.

Justin Tollman discussed the insurance renewal with the board.

Ryan Powers and Tim Brewer, USDA-Aphis Wildlife Services met with the board to discuss progress on hiring an individual for predator control services. Vic Rivera and Wally Juhlin, Dawes County Commissioners and Steve Burke, Box Butte County Commissioner were in attendance as well. State and Federal funding to help with predator control is needed. A plane is available now, and Powers is hoping to get someone hired and on board soon.

There being no further business to come before the meeting was adjourned at 2:22 p.m. The Sioux County Board of Commissioners will meet March 2, 2026.
